MEMORANDUM OF UNDERSTANDING

BETWEEN

THE GOVERNMENT OF THE REPUBLIC OF INDIA (GoI)

AND

THE GOVERNMENT OF THE PEOPLE'S REPUBLIC OF BANGLADESH (GoB)

FOR

EXTENDING A NEW LINE OF CREDIT (LoC) OF US\$ 2 Billion BY GOI TO GOB.

The Government of the Republic of India (hereinafter referred to as 'GoI') and the Government of the People's Republic of Bangladesh (hereinafter referred to as 'GoB'), hereinafter jointly referred to as the 'Parties'.

BEARING in mind the friendly relations between the two countries;

RECALLING the Economic Cooperation between GoI and GoB in the past for the social and economic development of Bangladesh;

RECOGNIZING the contribution of the past Indian State Credit/LOC towards promoting development of infrastructure in Bangladesh;

RESPONDING to the request of GoB to GoI for extending a New Line of Credit (LoC);

HAVING considered the necessity of enhanced investment in socio-economic sectors of Bangladesh;

NOTING the established institutional framework in Bangladesh for utilizing the Line of Credits extended by GoI to GoB;

HAVE reached the following understanding:

The GoI agrees to extend a New Line of Credit (LoC) of US\$ 2 (Two) Billion to GoB with the same rate of interest per annum and same tenor/moratorium as agreed in the existing Line of Credit extended to Bangladesh by India.


Economic Relations Division, MoF, GoB and the Development Partnership Adinistration (DPA), Ministry of External Affairs, GoI, through the EXIM Bank of India, will jointly be responsible for formulating and signing of the Loan Agreement for the New LoC. Projects which are critical for social and infrastructure development in Bangladesh, such as, in Power, Railways, Road Transportation, Information & Communication Technology, Shipping, Health, Technical Education sectors will in principle be considered for financing under the New Line of Credit of US\$ 2 Billion. An indicative list of projects is appended to the MoU.

This Memorandum shall come into force from the date of its signing and shall remain valid till signing of the Loan Agreement for the New LoC.

IN WITNESS WHEREOF, the undersigned being duly authorized thereto by their respective Governments, have signed this MoU.
