13.	Tender Opening date and Time	Tenders will be publicly opened as follows <b>October 5, 2014 at 1530 hours BST</b> at High Commission of India, House # 2, Road # 142, Gulshan-1, Dhaka. Intending Tenderers or their authorized representatives may attend the opening of tenders
14.	Eligibility of Tenderers	Contractors who satisfy the following criteria: i. Contractor's firms who have minimum 05 (five) years of general experience in construction works. ii. Successful completion of similar works in a package contract with Civil, Sanitary & Electrical Works during the last 05 (Five) years preceding tender submission date in any govt./semi govt./ autonomous body. I: 3 similar completed works costing not less than the amount equal to 40% of the Tender amount; OR II: 2 similar completed works costing not less than the amount equal to 50% of the Tender amount; OR III: one similar completed work costing not less than the amount equal to 80% of the Tender amount. The experience certificate for successful completion of a building & other related work shall have to be issued by the officer not below the rank of Executive Engineer/Project Manager of concerned Department/Organization. Similar work referred here unto for the purpose of this tender means, work in civil construction, plumbing, electric work of similar or same value & magnitude. iii. Average Annual Turnover: 30% of the tender price iv. Liquid Asset or Cash flow: 20% of the tender price v. Tender Capacity: Must satisfy by the Tenderer as per his/her quoted Tender Price. vi. Tenderer must have up to date Income tax clearance certificate from the Concerned Department. vii. Tenderer must have valid VAT Registration certificate from the Concerned Department. viii. Tenderer must have upto date Trade License. ix. The tender documents must have been purchased from the stated source. The Tenderer must include, as a part of his tender, attested copy of documents mentioned in Sl. No. (i), (ii), (iii), (iv), (v), (vi), (vii), (viii) to establish his qualifications to perform the Contract.
15.	Liquidity Damage	The liquidated damages for the whole of the Works are 0.5% (zero point five percent) of the final Contract Price per day. The maximum amount of liquidated damages for the whole of the Works is 10% (ten percent) of the final Contract Price.
16.	Defect Liability	The Defects Liability Period is 365 (Three hundred sixty five ) days
17.	Performance Guarantee	The Performance guarantee shall of an amount equal to 10% of the Contract Price stated in the Letter of Acceptance & shall be valid until a date 60 days from the date of expiry of Defects Liability Period.

18. Retention Money	The proportion of payments retained is 10 (Ten) percent from each interim payment certificate subject to a maximum of 5 (Five) percent of the total Contract Price.

P.O./D.D of Tk.70,00,000/- (Taka Seventy Lac) only for tender; should be submitted in the envelope containing Technical Tender.</b> The “Technical Tender” shall be evaluated first in order to determine the eligibility of the Tenderers to be included in the competition. The “Price Tender Document” of the Tenderers, who is/ are found eligible to compete in the priced Tender, shall only be opened.</p> <p>ii) The Agency/procuring entity reserves the right to accept or reject any or all the Tender without assigning any reasons whatsoever.</p> <p>iii) Two sets of Tender shall be submitted; one in original and one in copy. In case of any discrepancy between original and copy, the original shall prevail.</p> <p>iv) If the Tenderer submits any false/incorrect or forged certificates, its Tender will be rejected and the Tender security may be forfeited.</p>
